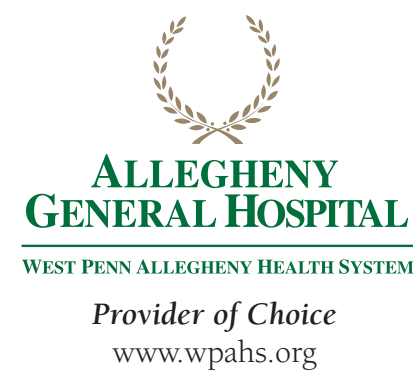

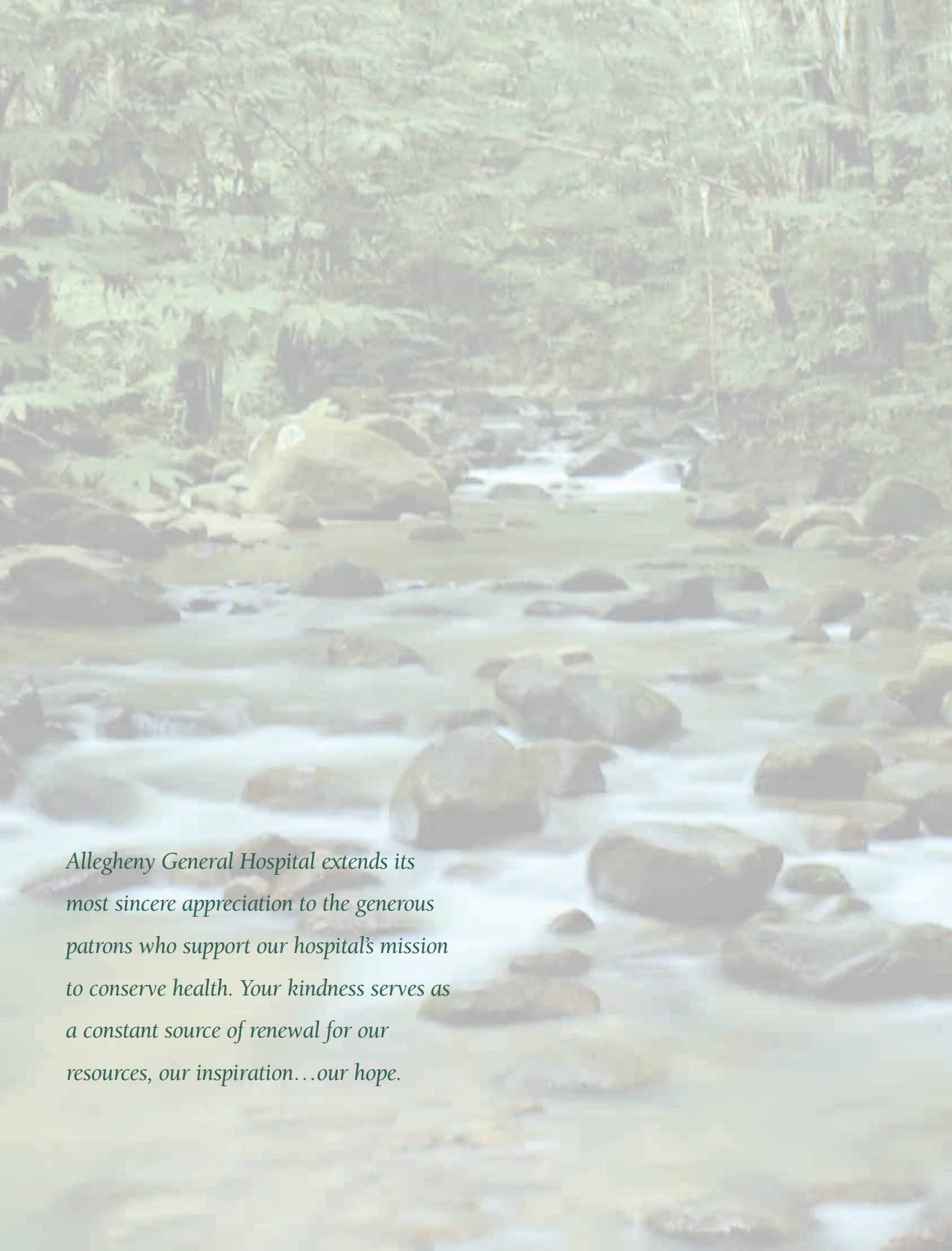

Renewal



The Year in Review

- Allegheny General Hospital was named one of the nation's top health care performance improvement leaders. The study reviewed a total of 2,800 U.S. hospitals in a variety of areas and identified AGH as among the top 100 performers. AGH shares this distinction with other fine institutions including Brigham and Women's Hospital, Beth Israel Deaconess Medical Center and Stanford University Hospital, to name a few.
- Allegheny General Hospital was ranked among the safest American hospitals in a nation-wide survey of safe practices that was conducted by The Leapfrog Group. AGH was the best of the best in eight categories as compared to 1,216 hospitals that participated in the survey. The categories include coronary artery bypass graft, abdominal aortic aneurysm repairs, bariatric surgery, and neonatal ICU service, to name a few.
- Specialists working within AGH's coronary care unit (CCU) celebrated a significant achievement in the hospital's nationally recognized campaign to enhance patient safety and quality of care — more than one year without a single central line associated blood-stream infection (CLAB). Hospital acquired infections are a significant problem in U.S. health care, with more than 250,000 infections occurring each year in hospitals nationwide.
- Allegheny General Hospital was recognized as a Neuroscience Center of Excellence in a recent survey of the nation's leading centers for the treatment and study of neurological disease. The annual Neuroscience Center of Excellence Survey is the only comprehensive analysis of hospital-based neuroscience programs in the U.S.
- According to the Tenth Annual HealthGrades Hospital Quality in America Study, Allegheny General Hospital ranks among the top 10 percent in the nation for stroke care services. This study, the largest of its kind, analyzed patient outcomes at virtually all of the nation's 5,000 hospitals over a three-year period ending in 2006. The study found that AGH is the best in the region for stroke care. The hospital recently opened western Pennsylvania's first dedicated inpatient stroke unit.
- Through the recruitment of leading congestive heart failure specialists and two heart transplant surgeons, and the grand opening of the Gerald McGinnis Cardiovascular Institute, Allegheny General Hospital performed 19 heart transplants during Fiscal Year 2007.
- The AGH Department of Orthopaedic Surgery, in response to a significant increase in patient volume, has begun construction of the Restorative Joint Disease Center at Allegheny General Hospital. This state-of-the-art unit, which features advanced facility design, equipment and furnishings, and patient services, will cater specifically to the needs of orthopaedic patients requiring joint replacement. Opening in the spring of 2008, the center will be an attraction for patients within Pennsylvania and surrounding states.
